Membership Terms and Conditions

Members and their guests must treat the club and its staff and members with courtesy and respect at all times.

The member's code of conduct and codes of conduct within the building must be adhered to by members and guests at all times.

Use of the facilities of the club and use of the club premises is strictly subject to the rules and regulations of the club in effect at any time.

Payment of the annual membership will entitle the member to membership of SPORTSCO for a twelve-month period and all facilities and programmes must be paid for thereafter, per chosen option.

Membership must be renewed on the expiration of the twelve-month period.

In the event of the annual membership fee not being renewed within the day of its expiry, it is deemed to have expired and it will be necessary to re-apply for membership.

In the event of losing a membership keyfob, a €5 fee will be payable for the replacement.

Membership may be terminated by the Management for violation of any rules or regulations of the club or for conduct deemed by the Management to be detrimental to the welfare, good order, safety or character of the club or its members.

Membership is not transferable and membership fees are not refundable under any circumstance.

Any keyfob being used by any person other than the member will be confiscated and membership suspended pending investigation.

The member acknowledges that he/she is in good health and not suffering from any disease or illness.

A screening form must be filled in before using the gym.

Children under 10 years must be accompanied by an adult or guardian aged 16 yrs or over when entering the building.

Smoking is not permitted in any part of the building or anywhere on SPORTSCO grounds under any circumstances.

Members must be 16 years or over to use the gym or leisure suite areas.

Adult members are permitted to bring a maximum of two guests per visit and the member must be present with their guests at all times. Guest rates apply.

Members under fourteen may not bring guests to SPORTSCO.

Guests are not permitted to use the gym.

Children are allowed to be part of their family membership until their 21st birthday. If they are in full time education, they are permitted to take a student membership until their 25th birthday.

SPORTSCO will endeavour to ensure that all facilities and equipment are maintained in working order but the club accepts no responsibility to the members for failure or breakdown of any equipment or facility however caused.

In the event of any dispute arising between a member and SPORTSCO, the decision of the Management will be final.

The Management of SPORTSCO reserves the right to amend and add to these conditions of membership and rules as it sees fit and the member shall observe any amended or additional conditions or rules so made.

SPORTSCO reserves the right to request proof of family membership or couple status.

Membership fees and admissions will be reviewed annually. SPORTSCO reserves the right to amend membership or admissions fees as required.

SPORTSCO membership and club membership must be in place to avail of club hours.

On joining SPORTSCO, the member accepts and agrees to be bound by these conditions of membership of SPORTSCO.
